"Pilot Bill" for Legislation Committee Formulation

*HB 1101 was one of the bills The Villages was tracking, and I utilized it as my "pilot" tracking bill to help determine useful steps in tracking legislation.

- HB 1101- Courts for children three years of age and younger in need of service
 - Establishes a safe baby court as a type of problem solving court. Provides that a child in need of services is an eligible individual for purposes of a problem solving court program.
 - Every seven minutes, an infant or toddler is removed from home due to alleged abuse or neglect. When this happens, children are often placed in a child welfare system that has not developed policies and practices with the needs of infants and toddlers in mind.
 - The ZERO TO THREE Safe Babies Court TeamTM approach transforms child welfare into the practice of prevention and family well-being by using the science of early childhood development to meet the urgent needs of infants and toddlers.
 - The program connects very young children and their families with needed community support and services, with a goal of advancing health and well-being.

Prevent Child Abuse America Issues Focus for 2024

- 1. Federal Fiscal Year 2024 Appropriation Recommendations: Advocation for investments in children that will help set them up and thrive through the federal appropriation process
 - a. Each year the president submits a budget to Congress for the federal government every fiscal year
 - b. Fiscal year: October 1 through September 30
 - c. Congress must then pass appropriations bills to provide money to carry out government programs for that specific year
 - d. PCA America made recommendations for increases in Fiscal Year 2024.
 - i. Highest funding possible to support investments which result in significant positive outcomes and safe, stable, and nurturing relationships and environments for all children
 - e. The federal supports are proven to prevent child maltreatment to ensure children reach their full health and potential.
 - f. Priorities include: increased investment for Community-Based Child Abuse Prevention (CBCAP) program, child sexual abuse prevention, and adverse childhood experiences.

2. Child Tax Credit (CTC)

- a. The Child Tax Credit (CTC) in the American Rescue Plan provides the largest Child Tax Credit ever and to the most working families ever. As of July 15th, most families are receiving automatic payments.
 - i. Help ease the burden of rising costs and impact of the current pandemic
 - ii. Helping all families succeed
 - 1. Families struggling to cover basic needs like food, rent, and other bills
 - 2. Middle-class families that need help with child care and college savings
 - iii. This critical support is set to expire
 - iv. House and Senate are finalizing the reconciliation package-annual federal budget process where Congress sets total spending, revenues, the surplus or deficit, and the public debt-decisions are being made on the CTC now.

- 3. Child Abuse Prevention Treatment Act (CAPTA)
 - a. Federal law that provides grants to states to support the prevention, assessment, investigation, prosecution and treatment of child abuse and neglect.
 - b. CAPTA supports front-end services that prevent system involvement and keeps families together whenever safely possible.
 - c. PCA America supports strong and comprehensive reauthorization bill that includes significantly higher funding levels, increases transparency and accountability in the program, increases the focus on primary prevention and family support services, and promotes race equity.
