### **Indiana's 2024 Legislative Session has Ended!**

The 2024 Legislative Session ended in early March as this year was a short session.

The Villages have utilized the Corydon Group to update their bill tracking on a daily basis. For the 2024 session, The Villages tracked a total of twelve bills, all of which were passed and signed by the governor of Indiana on March 11<sup>th</sup>! This session, bill interests included caregivers and parents, DCS, courts for children in need of services, child advocacy centers, family and juvenile law, childcare, adoption programs, and reunification plans for children.

For future sessions, PCAIN should aim to send out weekly updates in order to keep legislation subcommittee members accurately informed. This is also important in the case that members want to attend or testify in hearings at the Indiana State House.

Final actions on bills were set to end on March 14<sup>th</sup>, but both the House and Senate were able to adjourn by March 8<sup>th</sup>.
